Modernizing State and Federal Compliance Reporting at Mid Michigan College with Informer

How Mid Michigan College rebuilt its STARR reporting infrastructure, streamlined regulatory compliance, and created a sustainable framework for state and federal reporting success with Entrinsik's Informer.

Pain points

- STARR compliance reporting system broke down with no internal backup.
- Custom X-Screens failed, leaving staff unable to validate or submit critical reports.
- Only six weeks to rebuild reporting before regulatory deadlines.

- Rebuilt STARR reporting framework **4-5x faster** than traditional methods.

Mid Michigan College is a public, community college with campuses in Harrison and Mt. Pleasant, Michigan. Serving approximately 3,297 students with a 28:1 student-faculty ratio, the college offers over 600 courses each semester, including 100+ online classes.

Accredited by the Higher Learning Commission (HLC), Mid Michigan provides career-focused associate degrees and certificates in Liberal Arts, Health Professions, and Business Administration. As a member of the Michigan Community College Athletic Association, it also supports a vibrant student life experience.

Challenge

Mid Michigan faced an urgent crisis when their STARR (Student Transcript and Academic Record Repository Collection) reporting process broke down. The internal technical expert responsible for maintaining their custom-built Colleague X-Screens departed, and the X-Screens themselves stopped functioning.

Without a working solution, the college struggled to validate and submit critical state-mandated reporting, risking noncompliance. Staff had no visibility into how the reports were compiled, leaving them unable to verify data accuracy or adjust submissions with confidence.

To make matters worse, they had only six weeks to rebuild their STARR reporting process ahead of submission deadlines.

Mid Michigan needed a solution that could:

- Rapidly replace broken reporting infrastructure
- Integrate seamlessly with Ellucian Colleague
- Deliver transparency, flexibility, and scalability for future compliance needs

Solution

Mid Michigan partnered with Entrinsik to modernize its STARR reporting framework using Informer, shifting away from fragile legacy X-Screens toward a transparent, interactive reporting structure.

Working alongside Mid Michigan's staff, Entrinsik's Managed Services team:

- **Aggregated and structured data** across multiple Colleague tables
- **Built reusable, flexible report templates** for STARR and future compliance needs
- **Enabled full visibility** into how data is compiled and validated
